agreement as required by the District. NOW THEREFORE, in consideration of the mutual covenants, promises and agreements herein contained, it is hereby understood and agreed:

The District shall furnish, subject to the limitations set out in Rules and Regulations and those hereinafter provided for, such quantity of water as the user may desire in connection with his/her occupancy at the following address:

WHEREAS, the User desires to purchase water from Jeff Davis Central Wate District and to enter into a water users

The User shall install and maintain at his/her own expense a service line which shall begin at the meter and extend to the dwelling or place of use. The service line shall connect with the distribution system of the district at the nearest place of desired use by the User, provided the District has determined in advance that the system is of sufficient capacity to permit delivery of water at that point.

- o The User agrees to pay for water at such rates, time and place as shall be determined by the District and agrees to the penalties for noncompliance with the above as set out in the current Rules and Regulations.
- The District shall purchase and install a cutoff valve and may also include a water meter in each service. The
   District shall have exclusive right to use such cutoff valve and water meter.
- The District shall have final jurisdiction in any question of location of any service line connection to its distribution system and shall determine the allocation of water to user in the event of a water shortage.
- The User agrees to comply with the requirements of the Louisiana State Board of Health that no other present or future source of water will be connected to any waterlines served by the district's waterlines.
- User will disconnect from his present water supply prior to connection to and switching to the District's system.

### **WATER CHARGES:**

- o The User shall commence on the date that the service is made available.
- Failure of a User to pay water charges duly imposed shall result in the automatic imposition of the following penalties:

- Nonpayment within 15 days from the due date shall be subject to a penalty of \$10.00
- Nonpayment within 60 days from due date will result in the water being shut off from User's Property with a Reconnect Fee of \$50.00
